

# Privacy policy

Welcome to ESK-SIC GmbH

We place a very high value on your privacy and respect your privacy. Below we describe to what extent collecting and processing of personal data provides of our websites.

## 1. Anonymous data collection

When visiting our website, you can remain completely anonymous. Neither the name of your Internet service provider, nor the webpage from which you visit us, nor the name of the requested file is stored when you have objected to the tracking.

## 2. Collection and processing of personal data

A data collection is carried out only if you provide us your data when contact us via our contact form. Data entered by you in the contact form, such as name company, email address and telephone number we process for the purpose of personal communication with you.

Please provide us confidential information in any other way, because at this point, the data transmission is not encrypted. Personal data is only collected if you provide it as part of your order, when opening an account voluntarily. We use the data provided by you without your express permission, only for the processing of your order.

Your data will be transferred to the shipping company only if this is necessary for the transport of the ordered material. For the settlement of payments your payment data will be given to our responsible bank. No disclosure to other third parties.

## 3. Cookies

Our website uses so-called "cookies", which are used to make our website more user-friendly, more effective and more secure - for instance to enable faster navigation. Cookies also provide us with information about the frequency of page views of our website and about the general navigation. We advise you, that some of these cookies are transmitted from our server on your computer system, most of these are so-called "session cookies".

"Session Cookies" are automatically deleted from your hard drive at the end of your browser session. Other cookies remain on your computer sys-

tem and allow us to recognize your computer the next time you visit our website (so-called permanent cookies). You can, of course, always refuse cookies in your browser's settings at any time.

#### **4. Use of Google analytics**

Our website uses Google Analytics, a web analysis service of Google Inc. ("Google"). Google Analytics uses so called cookies, text files which are stored on your computer and enable an analysis of your use of the website. The information about your use of this website generated by the cookie (inclusive of your IP address) is transmitted to a Google server in the USA and stored there. Google will use this information in order to analyse your use of the website, compile reports about the website activities for the website operator and to provide other services relating to this website and internet use. Google may also disclose this information to third parties, if legally obliged to do so or if the third party concerned processes the data on behalf of Google. On no account will Google link your IP address with other Google data.

You can prevent the installation of cookies by setting your browser software to that option; however, please note that in that cases you may not be able to use all the functions provided by this website

By using the website, you give your consent for Google to use the data captured about you in the manner described above and for the purpose stated above. You can revoke your consent to data capture and storage for the future at any time. Please contact the address stated in our "Legal" section if you wish to do so. Alternatively, you can use the deactivation add-on of Google Analytics (<http://tools.google.com/dlpage/gaoptout?hl=en>) if this is supported by your browser.

Please note that this website uses Google Analytics with the anonymous IP module. This removes the last section of your IP address so that no direct link between you and the data is possible.

#### **5. Information rights**

In Germany, the "Federal Data Protection Act" grants you the right to free information about your stored data, and if necessary, the right to correction, blocking or deletion of these data.
